

KIWIFRUIT CROP - INVENTORY & SHIPMENTS AS OF DECEMBER 31ST

The harvested Hayward crop came in at 10 million 7-pound tray equivalents (3.5 million volume fill equivalents). This is a 14% increase over the 8.6 million tray equivalents (3 million VF) sold last season. Fourteen percent of the Hayward crop is in the organic category.


Non-Hayward varieties, which include gold and red varieties of the *Actinidia chinensis* species and a green variety called Mega Kiwi, packed out at 1.5 million tray equivalents (530,000 VF) compared to last year's crop of 1.2 million tray equivalents (424,000 VF). Most of the increase in this category came from the red kiwifruit.

As of December 31st, 39% of the projected marketable Hayward crop was shipped, which is in-line with the historical trend.



PRICING

The KAC collects pricing information from California kiwifruit handlers during the season. The following chart shows the weekly average FOB prices for Conventional Hayward kiwifruit for the past 7 seasons.



INTERNATIONAL KIWIFRUIT ORGANIZATION (IKO)

The KAC represented the United States at the annual International Kiwifruit Organization (IKO) conference held in Arta, Greece in late September. The IKO includes eight member countries: Chile, Italy, France, Greece, New Zealand, Portugal, Spain, and the United States. This year's conference featured notable highlights, including China's first-ever participation, insights into shifting consumer trends across Europe, and updates on Zespri's marketing expansion in the United States.

IKO member countries provide annual reports that include production and acreage data, biosecurity issues and industry trends and challenges. These reports are available on the California kiwifruit website.
